MINUTES

Saturday 18 October 9.30 - 12.00

1 ATTENDANCE AND APOLOGIES

The Assembly was attended by 49 delegates and guests representing of 25 of the 44 constitutionally recognised Member metropolitan regions and areas of the Network. This was more than the 50% required by the Statutes to form a quorum. The Sederunt is in Appendix 1.

Apologies were received from GCVSPJC and Catalunya (IET)

2 PRESIDENTIAL ELECTION

The Assembly agreed to make this the first item on the Agenda in order to enable a full discussion by all those attending.

The Secretary General reported that interest in standing for President had been explored with colleagues from four Member areas during the METREX London Conference. There may also be other potential candidates. In these circumstances the Secretary General advised that the provisions in the Statutes for a Presidential election should be followed. This could either be electronic or at the forthcoming Paris Meeting in spring 2009.

The Assembly agreed to hold an election for the President of METREX at the Paris Meeting of the Managing Committee (meeting as a General Assembly) on Saturday 16 May 2009

In consequence, the procedures and timetable of events will be as follows.

- The Secretary General will formally advise Members of the election before the end of October 2008
- Nominations for President should be received in writing, by the Secretary General, three months before the election, that is by Friday 13 February 2009
- Nominations must be supported, in writing, by one other Member
- Candidates should include, with their Nominations, a short electoral Statement setting out their intentions as President. Candidates may wish to have regard to the METREX Intentions publication
- Nominations and Statements will be placed on the METREX web site and circulated to Members by e-mail before the end of February 2009
- The election will be by a simple majority vote through a secret ballot at the Paris
 Managing Committee Meeting (meeting as a General Assembly) on Saturday 16 May

 2009
- Candidates may wish to address the Meeting/General Assembly prior to the election

At the moment there are 44 Member metropolitan regions and areas with the right to vote (see Appendix 2). Where areas have multiple Members (for example, a region, province and city/community) they will have to decide which candidate to support with one collective vote.

Member areas may vote by letter, fax or electronically. They may delegate another Member, in writing, to cast their vote for them if they cannot attend the Paris Meeting.

The Secretary General will issue Voting Papers to all Member metropolitan regions and areas one month in advance of the election, that is, by Friday 11 April 2009

All politician members of METREX are recognised by the AISBL Statutes as Vice Presidents. Members are asked to confirm the politician members of METREX whom they wish to have recognised and confirmed as Vice Presidents

3 MINUTES OF THE AMSTERDAM MEETING OF THE MANAGING COMMITTEE (MC)

The General Assembly approved the Minutes of the Amsterdam meeting of the Managing Committee, which took place on Saturday 17 May 2008

4 INTERNATIONAL AFFAIRS

4A European Neighbourhood Policy

DG RELEX has written to confirm that it is possible to organise a small consultative meeting where up to five invited colleagues from EU neighbouring countries could be reimbursed for their trip to Brussels. DG RELEX has indicated that St. Petersburg, Minsk, Lviv, Chisinau, Odessa and Alexandria could be eligible if adequate partners can be found on the EU side.

Possible METREX partners at such a meeting could include Helsinki, Vilnius, Wroclaw/Krakow, Bucharest, Sofia and Athens/Thessaloniki. The METREX Ambassadors might also participate.

The Secretary General will confirm the interest of METREX Members in participating in an exploratory meeting in Brussels, hosted by DG RELEX, to exchange knowledge on issues of common interest and to develop working relationships. Thereafter the arrangements will be progressed through DG RELEX

4B METREX/Shanghai International Study Visit - 10-18 November 2007

Colleagues from the Shanghai Municipal Government Urban Planning administrative Bureau (SUPB) attended the METREX London Conference.

Xiaocun Ruan will explore the basis for continued cooperation with colleagues from Shanghai and the Secretary General will make a report to the spring 2009 Paris Meeting

4C Moscow International Seminar

The International Co-operation Programme, signed at Szczecin, has been proceeding and will conclude in 2008/2009.

The Secretary General, in consultation with colleagues from the Institute for the General Plan of Moscow (GUP NIIPI), will report on the outcome to the spring 2009 Paris Meeting

4D Latin America Study Visit - October 2009

Preliminary expressions of interest in the Study Visit have been received from Frankfurt, Stockholm, Mazovia, Sofia and Rotterdam. With Madrid and METREX representatives this would make a delegation of perhaps 8-10. This is about the minimum size of delegation. A formal programme for the Study Visit and an outline of the arrangements has been received by Alberto Leboriero of the Comunidad de Madrid from colleagues in the Chilean Ministry of Planning (see Appendix 3).

On this basis all METREX colleagues will now be asked to confirm their interest in participating to the Secretary General and the Study Visit leader Alberto Leboriero

5 EUROPEAN AFFAIRS

5A Brussels Open Days

The Secretary General will continue to facilitate the formation of a METREX Conglomerate to participate in the Brussels Open Days in 2009, if future themes are of sufficient interest to Members

5B METREX/Washington Conference

DG RELEX has clarified that the next Call for Proposals under the EU Transatlantic civil society dialogues EU-USA Programme will be in 2010 but will not include the issue of environment.

The participation of colleagues from the US in the USEUCO2 project will now be pursued through other means of cooperation and financial support and a report back made to the spring 2009 Paris Meeting

5C ESPON

The background to the new ESPON 2007-2013 Programme was set out in detail in the Amsterdam MC Agenda Notes. Professor Cliff Hague, of the RTPI (the UK ESPON Contact Point) attended the meeting and explained the possibilities for future METREX/ESPON cooperation and relationships under the Programme.

In early 2009 there will be a Call for Proposals from ESPON national Contact Points (ECP) for Trans-national Networking Activities. The call will open in February and close in April with decisions expected in June. Professor Hague has suggested to fellow ECP that one possibility might be a proposal for a project on the implications of ESPON studies for metropolitan areas.

For example, there might be an opportunity to link with METREX on the dissemination of ESPON metropolitan area findings, to hold a joint event, or to cooperate with individual METREX Members on activities of common interest. Given that ESPON will by then have projects running on Cities, on Territorial Indicators and also a Manchester-Barcelona-Lyons-Dublin study, there should be new material to share.

The Secretary General will continue to liaise with Professor Hague (UK ESPON contact point) on his proposed project on the implications of ESPON studies for metropolitan areas. The outcome could be reported back to the spring 2009 Paris Meeting

5D EU Green Paper on Territorial Cohesion

METREX was invited to participate in the Hearing on Territorial Cohesion on 15 April 2008 and made a written submission (see METREX web site). On 6 October DG Regio launched their consultation period on the Green Paper on Territorial Cohesion, which will end on 29 February 2009 (see DG Regio web site).

The questions listed In Appendix 4 cover the main issues described in the Green Paper and define the scope of the debate it is intended to initiate. The Commission will provide a synthesis of this debate in late Spring 2009.

The General Assembly agreed that METREX should to liaise with other EU bodies and networks with an interest in Territorial Cohesion and to exchange responses to the Green Paper. Such bodies will include the EESC, Eurocities and PURPLE. The Secretary General will develop the METREX response having regard to the previous written submission and Appendix 2

It is understood that the French Presidency (July to December 2008) will take a particular interest in Territorial Cohesion and it will therefore be an issue for further consideration at the spring 2009 Paris Meeting

6 METREX INITIATIVES AND PROJECTS

6A EUCO2 80/50 project on Climate change/Urban change

The EUCO2 80/50 partnership met in City Hall, London, on the afternoon of Wednesday 15 October to explore options through which to progress the project. 18 of the 22 partners attended, including METREX. The following proposals were tabled by the Lead Partner and discussed.

- 1 Partners complete Step 1 (Assessments/Inventories) at their own expenses, starting with an Inception Meeting in Hamburg in January 2009.
- 2 Partners resubmit a revised project comprising Steps 2 and 3 (Scenario and Strategy Workshops) to the Interreg IVC secretariat.
- In parallel alternative funding possibilities are explored, for example, through a private sponsor or an independent institution or organization.
- If options 2 and 3 are not productive then those partners who are able will continue at their own expense.

The Lead Partner's proposal was unanimously welcomed. 13 partners decided to continue with Step 1 and 5 partners have to check on the available funding for Step 1. 2 partners did not participate in the London meeting and 1 has decided to withdraw.

All partners emphasised that a greenhouse gas (GHG) Inventory has to be made in order to develop a metropolitan mitigation strategy. The costs of contracting GRIP services would be significantly less than on the open consultancy market.

The Lead Partner and METREX put the proposals in more concrete terms as follows.

- Inception Meeting in Hamburg to provide GRIP Inventory tool training and information Arrival evening Monday 12 January Departure evening Thursday 15 January or morning of Friday16 January
- Interregional Workshops (4 or 5) among newly formed groups that minimise travel costs and language problems. They will be formed after final partner decisions on participation. The Workshops are planned for a final control of the partner Inventories and will include preliminary training on the GRIP mitigation scenario tool.
- 3 Synthesis Meeting of the partners at the METREX Paris Meeting in May 2009, where a whole day will be reserved to this purpose and where Steps 2 and 3 will be prepared.

The Inception Meeting and the Workshops will be provided by the Lead Partner and the hosting partners in partner premises without expenses for the other participating partners. METREX will pay the travel costs for Tyndall during this period.

Partners could share the Step 1 costs of €100,000 for GRIP services to May 2009 on the following basis.

- 14 partners participating @ €7,150 each
- 15 partners participating @ €6,660
- 16 partners participating @ €6,250
- 17 partners participating @ €5,880
- 18 partners participating @ €5,550
- 19 partners participating @ €5,260
- 20 partners participating @ €5,000

The Lead Partner is seeking a clear statement of participation from every partner by Friday 31 October 2008 and confirmation of their participation in the Inception Meeting

The Secretary General will prepare a revised budget for the EUCO2 80/50 project resubmission under Interreg IVC and circulate this to partners

A meeting will also be sought with the Interreg Secretariat to clarify its understanding of GRIP and the acceptability of the project management arrangements (Workshops etc.), project budget and Application text

6B Expert Group on Major Infrastructure in Metropolitan Regions

The first meeting of the Expert Group on Major Infrastructure was held in Stuttgart from 22-24 November 2006. A full Report on the meeting can be downloaded from the METREX web site together with the presentations that were made.

A further meeting of the Expert Group, in Berlin, will be arranged for spring 2009

6C Proposed Expert Group on Employment relocation within metropolitan areas

Colleagues from Frankfurt, Amsterdam, London, Sofia and Regione Piemonte (possible) have expressed an interest in participating in this Expert Group to be led by IAU Region Ile-de-France. The General Assembly Agenda Notes (Appendix 4) set out the intentions of the Expert Group in more detail.

The Group will work towards a Workshop contribution to the METREX spring 2009 Paris Meeting

6D Proposed Expert Group on Polycentricity in Metropolitan Areas

Colleagues from Sofia, Saxon Triangle, Frankfurt/Rhein-Main, Emilia-Romagna, Napoli, Veneto, Mazovia, Gdansk-Sopot-Gdynia, Helsinki, City of Stockholm have expressed an interest in participating in this Expert Group to be led by Stockholm County Council. Nordregio has expressed an interest in providing consultancy/facilitation services.

Stockholm County Council will now proceed with arrangements for Expert Group working as set out in Appendix 5

6E Contacts between METREX and PURPLE

Heiko Kasseckert, of Planungsverband Ballungsraum Frankfurt/Rhein-Main, has been elected Vice President of PURPLE (Peri-Urban Platform Europe) responsible for expansion. His colleague Reinhard Henke is facilitating contacts between METREX and PURPLE. From the PURPLE web site (www.purple-eu.org) it would seem that cooperation might be possible on the EU Green Paper on Territorial Cohesion and on climate change and the issues of mitigation and adaptation.

The Secretary General will liaise with PURPLE on these and other matters of common interest

6F Renewal of older metropolitan drainage infrastructure

Kevin Reid explained that this is as issue within the Greater London area and that an outline will be circulated for Expressions of Interest

6G Proposed Hamburg Conference on Social Inclusion - spring 2009

The Metropolregion Hamburg has in mind to hold a Conference on social inclusion in metropolitan areas in spring 2009. It could consider inter-related issues such as the social and economic integration of immigrants and their relationship with the housing market, particularly affordable housing. Aspects of multi-culturalism might also be considered. Affordable housing was also regarded as an issue worthy of Expert Group consideration in its own right.

The Metropolregion Hamburg will draft a Call for Expressions of Interest for circulation to METREX Members

7 FINANCIAL REPORT, ACCOUNTS AND AUDIT FOR 2008 AND BUDGET FOR 2009 TO 2010

7A/B Financial Report and Accounts and METREX audit for 2008 (from January to June 2008)

The Financial Report and Accounts, circulated separately from the Agenda Notes, were presented and explained by the METREX Accountant, John Brown. Particular mention was made of the provision for the EUCO2 80/50 project and the planned end of year credit balance to accommodate any cash flow problems with Interreg IVC co-funding.

The half-year position was reported to be satisfactory but John Brown warned of potential cash flow problems arising from the London Conference if all delegate fees and outstanding Member subscriptions are not now received before the end of October 2008

7C METREX Budgets for 2009 and 2010

The METREX Budgets for 2009 and 2010 were approved by the General Assembly. Revised Budgets will be tabled if the revised EUCO2 80/50 project is not approved or approved with Conditions (see item 6A).

INTERNATIONAL MEETING OF THE NETWORK OF EUROPEAN METROPOLIITAN REGIONS AND LATIN AMERICA WITHIN THE CONTEXT OF THE VISION FOR NATIONAL DEVELOPMENT TO 2020

INTRODUCTION

The Ministry of Public Works is undergoing a process of reflection to gain a view of the country within a perspective of development to 2020. The aim of this is to strategically align the provision of infrastructure services in order to increase the levels of competitiveness of all sectors of the economy and improve the housing conditions and quality of life of its citizens.

Within the context of this period of reflection, the main trends both international and national have been analysed, and the provision of infrastructure services for the city-region is one of those that most stood out due to the strength of the impacts it creates from the point of view of settlement and land occupation and the demands it entails from the planning perspective.

At the meeting of the United Nations Population Fund last year, it was revealingly observed that "In 1800, London was the only city with around 1 million inhabitants. In 1950 there were 8 cities in the world with a population of more than 5 million. According to demographic projections for the year 2015 there will be 47 cities with a population of more than 5 million, 23 of which will have more than 10 million inhabitants, and for the year 2020 the world will have 20 cities with a population of more than 20 million.

Next year, in 2008, more than half the world population of 3,300 million will live in urban areas. The projections reflect the fact that by 2030 this figure will have reached almost 5,000 million. Although over the last 200 years the world has experienced a strong process of urbanisation, over the next decades there will be unprecedented urban growth which will mainly take place in the developing countries."

Projected data and tendencies for Chile are also revealing. According to INE projections for 2050, Chile will have a population of 20,204,779 representing a growth of 24.2% from 2005. For the year 2020 the projected population will be 18,549,095, of which 87.2% will be urban population and the remaining 12.8% rural population.

Likewise, some interesting trends can be observed today, the main one being a greater relative growth of middle-sized cities in percentage terms, in comparison with the large metropolitan regions of the country.

This situation poses a series of challenges that need to be met and worked out in a systemic manner by all the actors, both public and private, that implement actions with a direct impact on metropolitan regions and cities.

It is in this context of challenges and concerns that the study visit and International Congress in Santiago (Chile) in October 2009 will be held, following contacts made by METREX, the Network of European Metropolitan Regions and Areas, with the Ministry of Public Works for the organisation of this event.

In turn, the Ministry of Public Works, understanding the complexity of the issues in question and the competencies required to deal with all the aspects that need to be addressed, invites the Ministry of Housing and Urban Planning, the Ministry of Transport and the Regional Government of the Santiago Metropolitan Region in order to address this challenge in a concerted manner.

AIMS OF THE CONGRESS

General aim

Exchange of experience in spatial planning and development between European and Latin American metropolitan regions, through case studies and specific experiences in those territories, in order to create an agenda of collaboration with a view to addressing future challenges.

Specific aims

- Analyse those urban development trends and models that have been observed in the main Latin American and European metropolises, identifying patterns that can be applied to the reality of Latin American cities.
- Discuss prospective scenarios that estimate the likely evolution of cities in 2020, identifying planning requirements and challenges.
- Promote the exchange of national and international experiences that may enrich the development proposals of the key metropolitan regions.
- Find out the strategies and tools that are used for spatial planning and the provision of infrastructure services, identifying areas of implementation for Latin American cities.
- Disseminate the proposals and experiences that have been systematised in the various metropolitan regions in order to progress the development of proposals for specific plans to be carried out.

SCOPE AND ORGANISATION OF THE CONGRESS

The Congress will take place in October 2009 and it will have four components.

- 1 Field visit (one day)
- 2 Conference with a series of presentations related to the metropolitan dimension and case studies of metropolitan cities of Europe and Latin America (two days)
- Internal meeting with the European and Latin American delegation to agree conclusions and a future work agenda (one day)
- 4 Production of the Congress publication.

The organization of the Congress will be through a Joint Committee with two focal points.

Chile

Organising Committee. Made up by GORE Metropolitano, the Ministry of Housing and Planning (MINVU), the Ministry of Transport, SECTRA, and the Ministry of Public Works (MOP) which will have the coordination role through the Planning Director, Ms Vivien Villagran.

Europe

METREX Contact. This network's participation will be through an Organising Committee coordinated by the Comunidad Autónoma de Madrid in the person of Mr. Alberto Leboreiro Amaro, Subdirector General de Planificación Regional, Department of Urban Planning and Territorial Strategy, Ministry of the Environment and Spatial Planning and Development.

PARTICIPATION

We will invite relevant public and private decision makers in the fields of urban and spatial planning, decentralisation and regional strategies, associated with experience in development in metropolitan cities and regions, in order to consider current issues and future challenges that can be addressed through a comparative analysis, with the objective of achieving a more harmonious and sustainable occupancy of the territory, together with an improvement of the housing conditions and quality of life of their citizens.

ACTIVITIES OF THE CONGRESS

- Field visit of the Metrex team and Latin American invited participants, in order to get to know the reality and challenges faced by the Santiago Metropolitan Region. The field visit will be in the Santiago Metropolitan Region, in order to present the current situation and the main challenges posed by the planning and development of this region up to 2020.
- International Conference of Metropolitan Regions of Europe and Latin America 2009. Exchange of Chilean and International experiences on issues associated with city/territory relations in metropolitan regions, as contributions to the new challenges of spatial planning and development (from a practitioner/politician perspective) in this type of region and the identification of future common lines of work.
- Internal Workshop with the organising bodies and external guests. Compared assessment of Chilean and International experiences as a basis for the development of a shared agenda in order to improve the spatial development processes and commit on lines of action for a future collaboration agenda.
- Dissemination and Production of a technical paper with the case studies, presentations and finding and conclusions of the Congress.

Green Paper on Territorial Cohesion - Questions for debate

The questions listed below cover the main issues described in this Green Paper and define the scope of the debate it is intended to initiate. The Commission will provide a synthesis of this debate in late Spring 2009.

1 Definition

Territorial cohesion brings new issues to the fore and puts a new emphasis on existing ones.

- What is the most appropriate definition of territorial cohesion?
- What additional elements would it bring to the current approach to economic and social cohesion as practiced by the European Union?

2 The scale and scope of territorial action

Territorial cohesion highlights the need for an integrated approach to addressing problems on an appropriate geographical scale, which may require local, regional and even national authorities to cooperate.

- Is there a role for the EU in promoting territorial cohesion? How could such a role be defined against the background of the principle of subsidiarity?
- How far should the territorial scale of policy intervention vary according to the nature of the problems addressed?
- Do areas with specific geographical features require special policy measures? If so, which measures?

3 Better cooperation

Increased cooperation across regional and national borders raises questions of governance.

- What role should the Commission play in encouraging and supporting territorial cooperation?
- Is there a need for new forms of territorial cooperation?
- Is there a need to develop new legislative and management tools to facilitate cooperation, including along the external borders?

4 Better coordination

Improving territorial cohesion implies better coordination between sectoral and territorial policies and improved coherence between territorial interventions.

- How can coordination between territorial and sectoral policies be improved?
- Which sectoral policies should give more consideration to their territorial impact when being designed? What tools could be developed in this regard?
- How can the coherence of territorial policies be strengthened?
- How can Community and national policies be better combined to contribute to territorial cohesion?

5 New territorial partnerships

The pursuit of territorial cohesion may also imply wider participation in the design and implementation of policies.

- Does the pursuit of territorial cohesion require the participation of new actors in policymaking, such as representatives of the social economy, local stakeholders, voluntary organisations and NGOs?
- How can the desired level of participation be achieved?

6 Improving understanding of territorial cohesion

 What quantitative/qualitative indicators should be developed at EU level to monitor characteristics and trends in territorial cohesion?
