In the context of today's polycrisis, the Metropolitan City of Milan presents a metropolitan governance good practice focused on addressing interconnected sustainability challenges through its role in local economic development. The initiative strengthens decision-making through data-driven analysis and a laboratory-based approach to knowledge co-creation with public and private territorial stakeholders.

Developed at the metropolitan scale, the practice combines strategic dialogue, shared vision-building and information services to support business resilience, address economic vulnerabilities and valorise supra-municipal identities and territorial vocations. It is further reinforced by the update of the 2006 OECD Territorial Review, implemented through an ongoing territorial scan and aligned with existing planning and sustainability frameworks.

In collaboration with universities and research centres, the initiative foresees three interconnected working groups – operational, steering and strategic – to support analysis, co-creation and supra-municipal projects. ### Option 1: City Tour – urban walk

Departure location: **Kymp House at 13:30**

The City Tour will focus on discovering and learning about the developing district of **Kalatatama**, one of the **City of Helsinki's major urban development areas**.

Kalatatama is a former container harbour. Its transformation into a new city district was made possible by relocating harbour operations to Vuosaari, approximately 12 kilometres east of the city centre.

Today, **Kalatatama** offers dense urban housing close to services and public transport. The area benefits from excellent connections in several directions. The sea is a constant presence: from Kalatatama, it is possible to walk across **Isoisänsilta Bridge** to reach the Mustikkamaa recreational area, or to walk, cycle or take the tram across the bay to Kruunuvuorenranta, another major development area.

Once construction is completed, a six-kilometre coastal route will run along the shores of Kalatatama.

During the City Tour, we will walk from the Urban Environment House to the Kalatatama district and explore some of the area's most distinctive features. One particularly topical and **important development site is the**
